- 2 days per week (annual total \$3,900.00) 3 installments of \$975.00 and the last installment of \$775.00\*
  - 3 days per week (annual total \$4,100.00) 3 installments of \$1025.00 and the last installment of \$825.00\*
  - 4 days per week (annual total \$4,600.00) 3 installments of \$1,150.00 and the last installment of \$950.00\*
  - 5 days per week (annual total \$5,100.00) 3 installments of \$1,275.00 and the last installment of \$1075.00\*
- Tuition installments are due on; August 1, 2012, October 1, 2012, January 1, 2013 and April 1, 2013.*

**I understand and agree that:** (a) our commitment to Gym\*Care is for the full school year, September to June, and that the total tuition has been divided into four installments for my convenience and **tuition payments are nonrefundable for any reason;** (b) a **\$50.00 registration fee and a \$200.00 security deposit are required at the time of registration;** (c) the total **\$250.00 amount paid at registration is NONREFUNDABLE for any reason,** except if my child cannot be accommodated at Gym\*Care; (d) the \$200.00 security deposit will be applied towards my April 1 installment and cannot be applied towards any other installment, charge or program; (e) a penalty charge of \$25.00 will be assessed against any installment which I owe and is not received by Gym\*Care within 10 days of its due date; (f) should my first tuition installment not be made on or before August 2, 2012, I will forfeit my child's place in Gym\*Care for the 2012-2013 school year; (g) should any tuition installment not be received within 20 days of its due date, Gym\*Care reserves the right to disallow my child's continued attendance until all arrears have been paid; (h) a \$20.00 fee will be assessed against all returned checks; and (i) Gym\*Care reserves the right, in its sole discretion, to request the withdrawal of a pupil at any time for reasons consistent with the best interest of the school; (J) **should I decrease the number of days my child attends Gym-Care for any reason, my tuition will remain at the higher rate.**
